Call to Order (Andrew)

Andrew called the meeting to order at 7:03 p.m.

Motion to Hold Executive Session

Motion: Board will suspend open meeting for the purpose of discussing matters involving the possible liability of an owner to the association. Moved to approve by John. Seconded by Karen. Discussion: None. Result: motion approved

Members in attendance were placed in "waiting room" while Board held its executive session.

Reconvene Open Meeting

At 7:17 PM, members are readmitted from "waiting room."

Motion: Accept the payment of all back dues and legal fees on the delinquent property. Second: Greg Discussion: none; motion passed unanimously.

May 26, 2022 Minutes (Katie)

Motion: Approve minutes of FCA Board Meeting dated May 26, 2022, as revised. Moved to approve by Greg. Seconded by Katie. Discussion: None. Result: motion approved

Verify members in attendance for minutes (John)

5 members were in attendance.

Introduce Board Members to members attending meeting (Andrew)

Members introduced themselves.

Budget Process and Proposals (Greg)

Greg presented the survey results (see below) before presenting a draft budget.

General satisfaction is favorable for all categories.

Trail usage: Over 75% of respondents use trails every day or several times a week.

Foxhall Park: Less than 25% of respondents use the parks more often than monthly.

New Projects: Highest rated of projects is 2.25 average on 5 point scale (Paved walking/running trail around park and dry weather dog park).

Compared with 2020 survey, the average level of support for new projects is less overall.

We don't know what proportion of respondents have children.

We may want to solicit more information from members, such as number/age of children for the purposes of planning improvement projects.

Greg presented a spreadsheet (see below) of past and proposed budgets: he suggested the need for a \$30 dues increase to offset anticipated increases in insurance premiums and mowing costs.

Member Survey Results and Board Responses (Greg)

Board members reviewed the survey results prior to this meeting. The Board considered adding responses to survey comments that could accompany a summary to share with the membership online. The Board reviewed Trail Committee responses to some comments.

The board will respond to question regarding the lighting at the upper entrance – will ask county if it can be upgraded.

Comments regarding the park are addressed later in this meeting.

Old Business

- Road Signs Karen, shared a table (see below) of existing signage and needs. Asked question of how to add signs to existing posts. Need to identify county signs and ask if we can add to their posts. Karen can ask County rep. Ask about size color. Six pairs of signs needed. Approximately \$25-35 per sign on Amazon.
- The ACC will provide an email to inform members of how they have acted on covenant interpretations, particularly regarding fencing.
- Past legal advice regarding the need for lien priority in covenants was summarized by John. To
 achieve first priority of Foxhall liens ahead of lender liens, the covenants and by-laws must be
 amended. The board must weigh the cost and effort of making these changes versus the
 potential need for establishing lien priority. Loan defaults and foreclosures are the risk when
 property values fall and equity vanishes, leaving nothing for secondary liens.

New Business

Discussed options of adding to or phasing-in improvements to play equipment. Greg will create
a facebook post inviting people to form a committee to study playground equipment
upgrades/options.



The playground equipment is getting old.


My 3s are because I don't use those things.

The trails committee is doing great work!!


Love Canyon Trail and all the trails, our great asset at Foxhall!


How often do you use Foxhall Park?

Overview

I checked all intersections at Foxhall for "NO OUTLET" and "DEAD END" Signs

Summary

- There are 9 intersections that warrant "NO OUTLET" or "DEAD END" signs
- 4 of these intersections have signs today
 - o 3 are "DEAD END"
 - o 1 is "NO OUTLET"
 - o 1 pair of the "DEAD END" signs needs replacement
- If we want all intersections to have signs
 - o 6 pairs of signs are needed
 - o I recommend using "DEAD END" for the new signs
- These new signs should be placed above the street sign
- Need to determine how to attach these signs to the existing wooden or metal poles
- Also suggest repairing/replacing:
 - o 1 of the 42nd CT signs
- Next Steps
 - o Figure out how to attach new signs
 - Summarize exact signage (with direction of arrows)
 - Summarize sources and prices
