I, Monica Wilder, declare as follows:

1. I am over the age of eighteen years old, competent, and make this declaration based on my personal knowledge.

2. I live at 4002 Foxhall Dr., Olympia, WA 98516.

3. I have lived in the Foxhall neighborhood, a community of 122 lots, for 35 years. I have experienced problem and property damage issues due to commercial equine activities.

4. Foxhall is served by a county road with large drainage ditches on both sides. Nearly 1/3 of the homes are on one-acre lots very close to the road like city streets, but without curbs and sidewalks, or on narrow dead-end roads without turnarounds. We have no parking space or facilities to handle commercial or public use of our park and trails.


