Request from Theresa that people call Board directly to offer help, ask questions, etc., rather than sending emails. Board is here to help. New members are still learning their jobs.

Budget Review

Ron. Thanks Carolyn Pendle for helping him.

Update: \$10,571 in checking account and \$62,027 in savings. Received 80% of dues. It takes 3-5 notices to get it all in. If all lot owners pay dues, we will have \$21,960, available

Budget process for this year: Board stated that it must with comply with RCW 64 38.025 which states that the Board adopts a budget and it is considered ratified unless a majority of lot owners vote to reject it. The vote can occur in person or by proxy.

Board commented that it wanted to discuss line budget items with members to answer questions and see where there was agreement about the budget. However, members cannot vote on the budget without a majority of lot owners represented. The Board recognized that this is a change from how it's been done because we have not been following the state law instituted in 1995.

Actions as meeting proceeded:

A motion was passed by Association members in attendance to vote on the budget regardless of the RCW or bylaws.

The Board stepped out to clarify the situation. The budget had been ratified by the fact that a meeting occurred. Insufficient (<50%) lot owners were present to reject the budget. The board did not know how to proceed with the motion that contradicted the RCW.

On returning, after discussion with the membership, the board agreed to get a letter from the Association's attorney to clarify the statute with case law.

Meeting was officially adjourned at 8:05 pm.

Discussion, however, continued and although the Board was amenable to reviewing the budget line by line, some meeting attendees continued to insist on voting. The board then terminated the discussion and again promised a letter from the attorney.

The members attending and the Board vacated the school premises.

During the meeting and post-meeting discussions various Association members expressed the following concerns and points:

That our own bylaws may allow us to bypass the RCW.

That the Board may be misinterpreting the bylaws.

The explanation offered by the Board as to why Association members can no longer vote on the budget was unclear and inadequate.

That Board may be trying to assume too much control over Foxhall.

That the Association members in attendance would be likely to pass the budget if a vote were to occur.
