Prior meeting minutes have been approved and passed.

Projects: north fence is almost complete (still needs gate work). The low branches of the trees in the park were trimmed up, but then a big windstorm blew more down. There is also fence damage due to a growing alder tree. There will be requests for estimates from 2 arborists.

Foxhall main entrance discussion: 1 1/2 yrs ago we had a plan that was completed. There is a new plan proposed for the entrance gate. A question was raised asking if we need to do more to the entrance. Discussion about dead plants, will a maintenance contract cover pulling out dead plants, spread out living plants to fix it, and maintain during summer. Should different (native) plants be used? There is an underground watering system started, but there needs to be a power source for it, and there would be a cost. We could use plants that don't need water in the summer.

There is money that we have in the budget to complete some of the tasks. The current piping that's there used to work until the county redid the road, cutting the water supply. Keith S. mentioned we were able to run a pipe from the other side of the road, and there is a box that used to cost \$25 to turn it on and off that we can meter off of if we want to. Paul Carlson said there is a hookup we could reattach. Discussion keeps coming back to are we done with what we had contracted for? The general consensus is yes. Paul Carlson said @\$400 to hook the water up and most seem to want to go for this. We have sprinkler system/tubing, just need the power hooked up. Theresa will talk to Paul Carlson about getting it hooked up, but the new submitted plan to redo the main entrance is too elaborate.
