Order of Business: Treasurer's report by Don. Don presented an overview of this fiscal year's actual expenditures to budget estimates. There was considerable discussion concerning trails improvements and increased expenditures for insurance. These discussions segued into a discussion of the Board's proposed budget.

After considerable discussion the Board's recommended 2018-19 Budget was accepted.

Order of **Business:** The Trails Committee presented a quick overview of their responsibilities and Jessica was acknowledged for her work as Chair of the committee. Greg Darnell was introduced as the new Trails Committee Chair.

Order of Business: By-Law change to Increase the Association Dues from \$180 to \$300. Don presented the Board's recommendation and rational for increasing the Association's annual dues.

A motion was made and seconded to amend the proposal reducing the Fee increase from \$300 to \$225. (The vote for the amended proposal was 22 yes and 35 no.) The amendment was defeated and the Board's recommendation was approved. The \$300 annual dues will be collected in the 2019-2020 fiscal year. (Vote to approve dues increase to \$300 annually was 36 yes and 18 no).

Order of Business: Volunteers were solicited to form a Park's Committee to explore options for utilizing our two parks.

Order of Business: Robert Jackson presented the Board's recommendation for a by-law amendment permitting mail-in and electronic voting. The issue of when proxy voting would be allowed was debated at length. A motion was made and seconded to table this issue until the opposing sides can clarify their concerns and the language they would use to implement these voting changes.

The motion passed and it was agreed to attempt to clarify the opposing proposals on voting for the next general membership meeting. (The vote to table this issue was 50 in favor and 5 opposed).

Meeting was adjourned at 8:31.

Minutes were approved at the 11.7.2018 Board Meeting. Chea abstained from voting on the approval of the minutes.
